



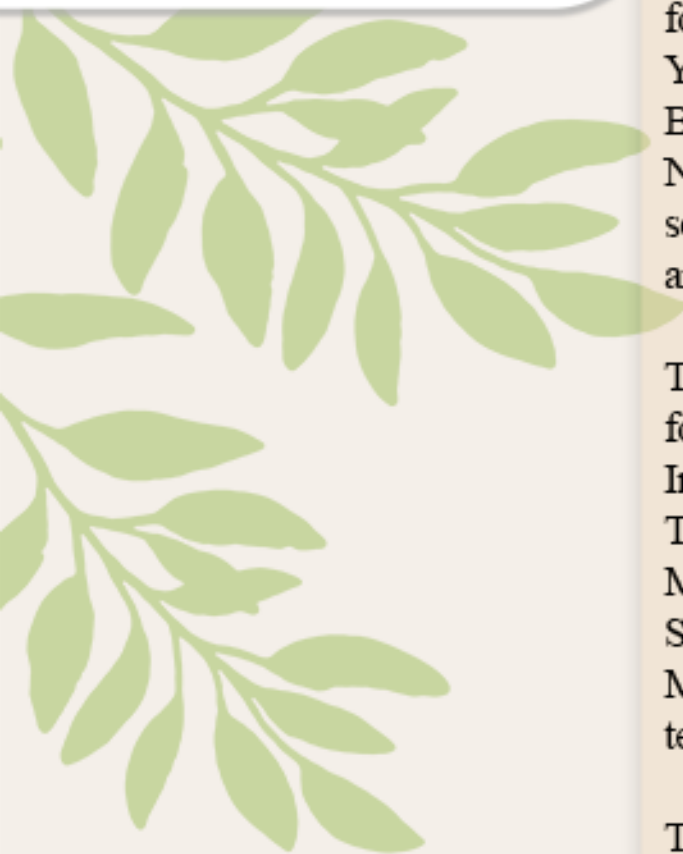

Health Check-Up for Students by Community Health Center (Puskesmas)

The comprehensive health examination conducted by the local Community Health Center (Puskesmas) included the following procedures; Basic anthropometric measurements (Weight measurement, Height measurement, Blood pressure check), Detailed physical examinations (Oral and dental examination, Ear examination, Nail hygiene assessment), Laboratory test (Hemoglobin (HB) level check)

Friday Community Clean-Up Initiative

In response to the Kupang Mayor's call for simultaneous community service under the program "**Kupang Shines: Clean and Green**", all educational institutions across Kupang City are required to participate in weekly clean-up activities every Friday from 7:00 AM to 9:00 AM (Central Indonesia Time).



Scope of School Clean-Up Activities:
Indoor Areas (Cleaning all classrooms, Maintaining work/office spaces), **Outdoor Areas** (School grounds maintenance, Cleaning within a 100 meter radius around the school premises), **Environmental Education Component** (School principals and teachers will educate students on **waste segregation** by category: Plastic waste, Organic waste, Non-organic waste) and disposed it in designated waste collection points

Graduation Approval Meeting for Class IX - Academic Year 2024/2025



The Graduation Approval Meeting is a pivotal moment for both the school and its students. This meeting involves the principal, vice principal, and faculty members to ensure that the graduation process adheres to all applicable regulations and criteria.

Graduation Requirements (Completion of the entire academic program from Grade VII to Grade IX, Achievement of minimum "Good" grades in all subjects, Passing the school written examinations, Passing all practical examinations, Fulfillment of the school's behavioral and conduct standards)

This formal process serves to validate students' successful completion of their junior secondary education, recognize students' dedication and hard work throughout their three-year academic journey, Maintain the school's academic standards and integrity.



In-House Training (IHT) for SMP TK School of Eagles Teachers

The In-House Training (IHT) program is an internal professional development initiative conducted at the school to enhance teacher competencies across various aspects of pedagogy and professionalism.
